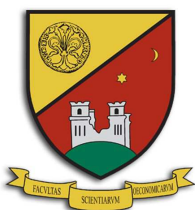

## ***Terms and deadlines:***

The papers will be written in English, B5 format, as the model (see document: Model Paper Doctoral Symposium Oradea) and will have exactly 4 pages. Power point presentations of the paper will be done in English, within 10-15 minutes/paper. Accepted papers will be published, after the review, in a volume with an ISBN / ISSN code, published by the University of Oradea.

The full paper (4 pages, including title and authors' names, contact and affiliation) will be sent by email (with the subject Paper for Conference) to [sesiunedrdec@gmail.com](mailto:sesiunedrdec@gmail.com) until 11<sup>th</sup> of November, 2021. The notification of acceptance of paper for presentation will be sent by email to the contact author until 16<sup>th</sup> of November, 2020. In order to be included in the Conference programme and to receive the Certificate of participation, authors should pay by 21<sup>st</sup> of November 2021, the registration fee of 100 lei (the IBAN account for payment will be provided within the acceptance email) and send the proof of payment by email. Please note that failing to email the payment order could result in failing to be included in the Programme. International doctoral students are exempted and kindly asked NOT to pay any fee, because we cannot issue an invoice.

Important deadlines:

- 11.11.2021: sending the paper by email to [sesiunedrdec@gmail.com](mailto:sesiunedrdec@gmail.com)
- 16.11.2021: notification of acceptance of the paper for presentation and inclusion in the Conference Programme
- 21.11.2021: payment of the registration fee (100 lei per participant) and emailing the payment order to [sesiunedrdec@gmail.com](mailto:sesiunedrdec@gmail.com)
- 25.11.2021: public release of the Programme.

Please note that, due to very strict timeline, no extension will be granted, under any circumstances.

By sending the paper together with the proof of payment (payment order scanned), participants agree that their papers will be scheduled for presentation.

After the conference, participants will receive the result of the review process and the request to send back the revised paper together with the Copyright form. There will be accepted for

*publication* only the papers submitted strictly within the deadline that fully comply with the requirements of formatting, in Economics and related areas (Business Administration / Economic Sciences) and meet the scientific requirements of such events. Publication of the accepted papers in the Conference Proceedings will be done after the session, by the end of 2021, with no additional fee.

The doctoral students may submit a maximum of two papers, either as sole author or with their Ph.D. coordinator, or with another doctoral student(s). There will be also admitted papers authored by post-doctoral students and young researchers.

### ***Publishing opportunities:***

The conference paper (4 pages) will be *published free of charge* in the conference volume (Emerging Markets Economics and Business. Contributions of Young Researchers. Proceedings of the 12th International Conference of Doctoral Students and Young Researchers), for those participants who have paid the registration fee.

Additionally, all authors could *submit extended versions* of their papers, with different title (between 8 and 10 pages, according to the journal's requirements), to be published in "The Annals of the University of Oradea. Economic Sciences" – Issues of December 2021/June 2022, journal indexed in multiple international databases, including ERIH PLUS: <http://anale.steconomieuoradea.ro/>. The extended papers will have to meet the journal's own criteria and they will pass through standard reviewing process. The extended papers are to be sent until 1<sup>st</sup> of December 2021 for the issue of December 2021. A publication fee will be charged, according to journal's policies (at the time of this Call the fee is 35 euros per paper).

A limited number of authors with outstanding presentations will be *invited to publish an extended version* of their paper, with different title (between 8 and 10 pages), free of charge, in "Oradea Journal of Business and Economics" – OJBE – Issue of March 2022, journal indexed in multiple international databases including ERIH PLUS: <http://ojbe.steconomieuoradea.ro/>.

### ***Fees and payment:***

There is a registration fee for participation in the conference of 100 lei (RON). Eventual travel expenses, accommodation and meals will be borne by the participants. Doctoral students who are members in the Organising Committee are exempt from paying the fee. There will be no additional fee for publication of the short paper (4 pages) in the Conference Proceedings.
